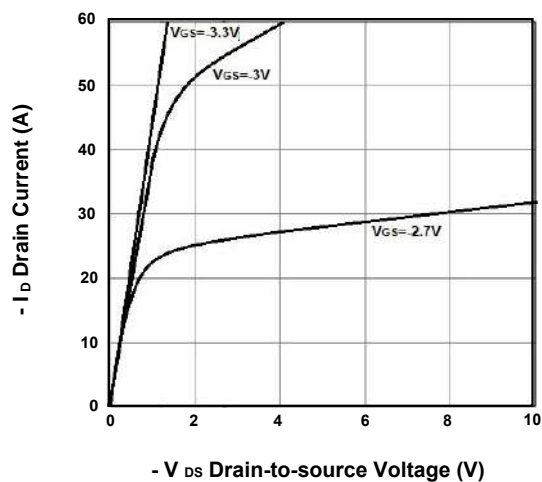


FIG.1-Typical Output Characteristics

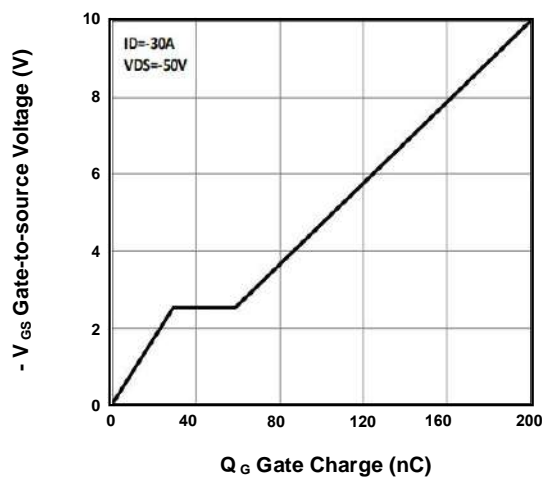


FIG.2-Gate Charge Characteristics

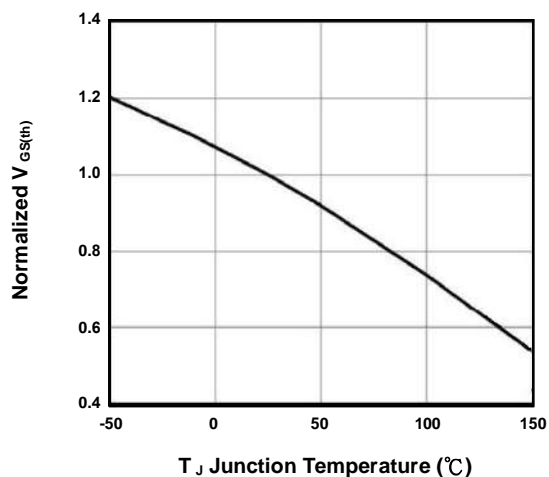


FIG.3-Normalized $V_{GS(th)}$ vs. T_J

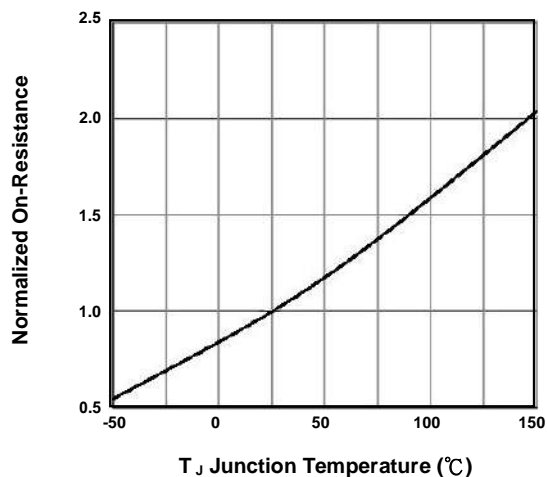


FIG.4-Normalized $R_{DS(on)}$ vs. T_J

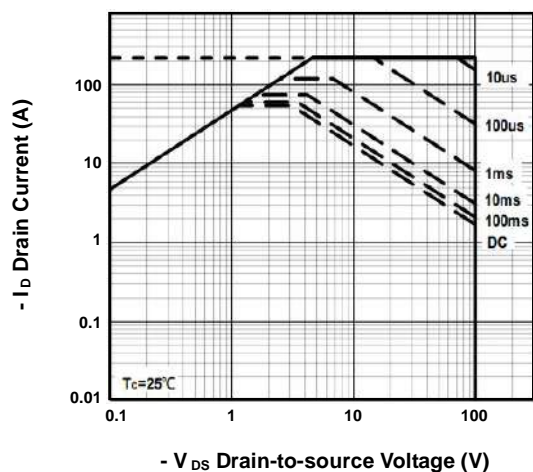


FIG.5-Safe Operating Area

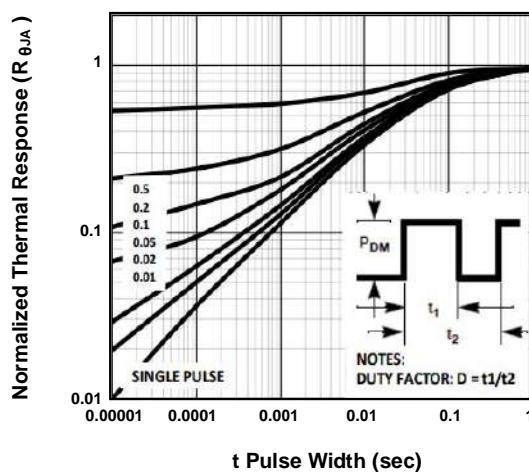


FIG.6-Transient Thermal Impedance

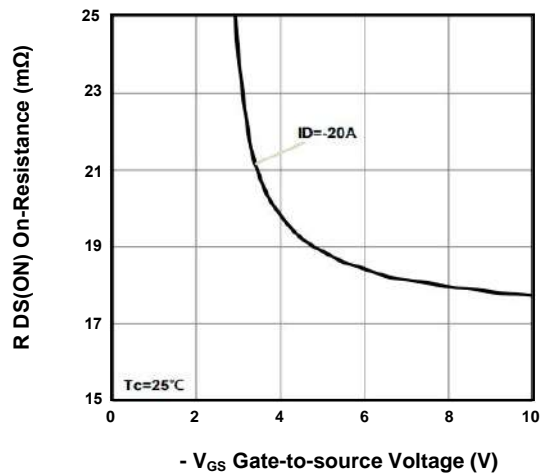


Fig.7- Turn-On Resistance vs. V_{GS}

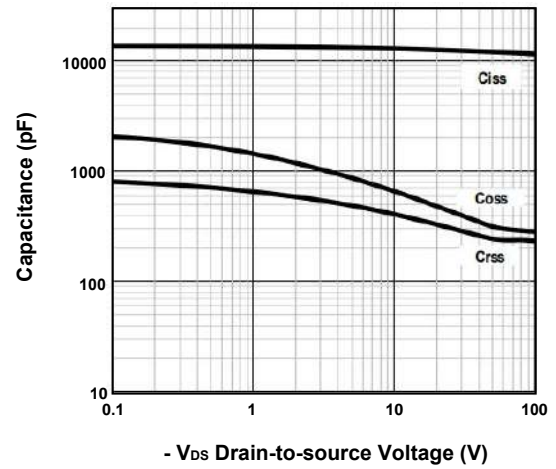


Fig.8-Capacitance Characteristics

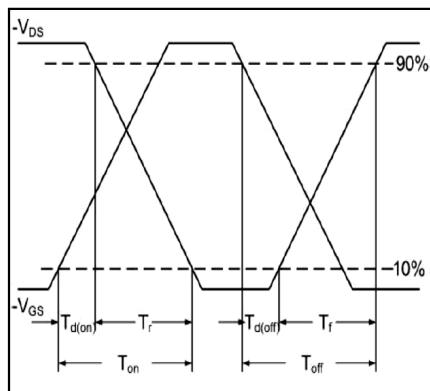


FIG.9-Switching Time Waveform

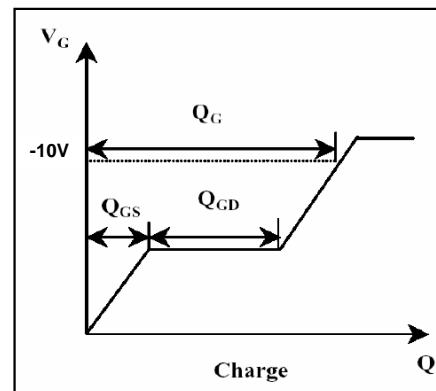


FIG.10-Gate Charge Waveform
